



Provisional seniority list of Assistant Town Planners, Class-I (Gazetted) of Town & Country Planning Department, H.P. indicating the position as on 1.1.2017 was circulated amongst all the concerned officers of the TCP Department vide this Deptt.'s Memorandum of even number dated 10.1.2017, for their information and inviting objections, if any, for which one month's time was prescribed for submission of representation, if any, to be given to the Issuing Authority.

Against this seniority list, representations from the incumbents who were recruited in this Deptt. on contract basis during the year, 2014 were received on the grounds that they may be placed above the Asstt. Town Planners who were promoted during the year, 2015 as they were recruited in the Deptt. in the year, 2014. The matter with respect to assign the seniority to the contractual employees from the date of their initial appointment or from the date of their regularization was examined in consultation with the Deptt. of Personnel, who have advised that the matter for assigning the seniority to contractual employees is under consideration. Therefore, as and when the Govt. takes decision to assign the seniority to the contractual employees from the date of their initial appointment, the seniority to the incumbents who were recruited on contract basis initially in the Deptt., would be assigned to them accordingly.

Besides this, the representation from one Smt. Nisha Kapoor, Asstt. Town Planner was also received on the grounds that she may be placed above Smt. Prem Lata, Asstt. Town Planner as she was senior to her in the feeder category i.e. in the cadre of Planning Officer. After having examined the representation of Smt. Nisha Kapoor, ATP, it was found that she was inadvertently placed below Smt. Prem Lata, ATP.

Now the final seniority list of Assistant Town Planner as on 1.1.2017, has been finalized as enclosed for being circulated amongst all concerned. Since this seniority list is now
