No: TCP-A(2)-2/2016.— In exercise of the powers conferred by sub section (1) of Section 77 of the Himachal Pradesh Town and Country Planning Act, 1977 (Act No.12of 1977), the Governor, Himachal Pradesh, by order, direct that the powers of the Director, Town and Country Planning under sections 30, 30-A, 31, 34, 38, 39, 39-A, 39-B, 39-C, 81 and 83-A of the Himachal Pradesh Town and Country Planning Act, 1977, (Act No. 12 of 1977) shall be exercised by the Executive Officers in respect of the areas falling under Municipal Council, Theog, Rohru, Ghumarwin, Sundernagar, Baddi and Kullu respectively and by the Secretary in respect of the areas falling under Nagar Panchayat Narkanda, Chopal, Mehatpur, Gagret, Nadaun, Sujanpur, Bhota, Jogindernagar, Talai, Bhunter, Baijnath-Paprola and Ner-Chowk respectively, from the dae of publication of this order in the Official Gazette. The exercise of the powers shall be subject to the following conditions:—

1. That the development permission is in accordance with the provisions of the Himachal Pradesh Town and Country Planning Act, 1977 (Act No. 12 of 1977), Himachal Pradesh Town and Country Planning Rules, 2014, regulations contained in the

Development Plans (if any) of the above referred areas as well as instructions and guidelines issued by the State Government and the Town and Country Planning Department Himachal Pradesh from time to time. Wherever necessary the above referred Municipal Councils and the Nagar Panchayats shall amend its Housing Bye-Laws to bring them in consonance with the provisions of Development Plan (if any) of the above referred areas and Himachal Pradesh Town and Country planning Rules, 2014 framed by the Town and Country Planning Department, Himachal Pradesh.

2. That the above referred Municipal Councils and Nagar Panchayats shall function under the overall control of the Additional Chief Secretary/Secretary (TCP) to the Government of Himachal Pradesh in respect of the powers delegated above.

- **1. Short titled and Commencement.**—(1) These rules may be called the Himachal Pradesh Higher Education Department, Post Graduate Teacher, Class-III (Non Gazetted), Recruitment and Promotion (Ist Amendment) Rules, 2011.
- (2) These rules shall come into force from the date of publication in the Rajpatra, Himachal Pradesh.
